Client Rights/Grievance Policy

Client Rights I understand my basic rights as a client. These rights include:

- You have the right to choose where you will receive services.
You have the right to know when and why your services end.
You have the right to know how fees are applied, and what your responsibility is.
You have the right to treatment in the least restrictive environment possible.
You have the right to have your opinions and preferences considered in any action that impacts your treatment.
You have the right to voice concerns, suggestions and grievances free from reprisal.
You have the right to services that are responsive to your age, gender, social supports, cultural orientation, psychological characteristics, sexual orientations, physical situations and spiritual beliefs.
You have the right to privacy and confidentiality.
You have the right to have your family involved in the treatment process.
You have the right to be involved in all aspects of treatment planning and review.
You have the right to be free from physical and psychological abuse, including sexual abuse or harassment, physical punishment and humiliating treatment actions.
You have the right to ask help in communicating any concern, suggestion or grievance you may have (from your referral source, a resource list agency, etc.)

Grievance Policy:

I understand that if I have a complaint/grievance, I should ask for:
A copy of the Client Rights Policy and Client Grievance Procedure shall be posted in a conspicuous location in the facility, Trinity Counseling Services LLC. Written copy of the Client Grievance Procedure is available to each applicant and each client, upon request. Appropriate staff will be available to assist a client in filing of a grievance.
